Membership fees permit participation in club activities (i.e.: fun nights, dances, demonstrations) or use of the arena/show grounds when there is no club activity planned. However, no private riding lessons or parties may take place on property. The member is responsible for any individual cost to (his/her/family) participation for/in a club activity. When the Show Season starts, it is the member's responsibility to sign up for and pay the appropriate entry fees. Points for yearend will only accrue the day of membership and there-after. **Member must compete 7 out of 9 shows and work 10 hours for first rider and 5 additional hours per rider maximum of 20 hours or have paid \$25.00 per hour for any hours not worked per season to be eligible for yearend awards.** A membership may be terminated for non-payment of dues, failure to comply with the written club By-Law requirements, conduct that endangers the welfare or character of the club, or by the member's resignation.

FOR AND IN CONSIDERATION OF THE SERVICES PROVIDED BY THE INDIAN RIVER RIDING CLUB, Participant does here-by forever and finally release, remise, acquit, satisfy, and forever discharge Indian River Riding Club of and from all manner of action and actions, cause and causes of action, suit, debts, sues, sums of money, bonds, billings, contracts, controversies, agreements, promises, damages, variances, judgments, executions, claims and demands whatsoever, in law or in equity, which may arise for or against the Indian River Riding Club, their agents, employees, representatives, successors and assigns for all present and future damages resulting from all incidents no matter how caused even those resulting from the negligent acts or omissions of said riding club.

This document is meant to be a full and complete release from any and all liabilities that may arise even though said liability or liabilities are predicted or based upon the alleged negligent acts of omissions of said riding club. This release is given freely and voluntarily by the Participant and is meant to remain in existence throughout the duration of use of the Equine. By entering into and executing this document, the Participant does so willingly and within the letter and spirit of and acknowledges reading and conforming to the provisions of Florida Statute, sections 773.01 – 773.05 (Chapter Law 93 – 169).
