I AGREE in consideration for my participation in the competition in the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach/trainer Or as a parent Or legal guardian of a Junior exhibitor, I am fully aware and Acknowledge that the horse sports and competition involves inherent Dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death("harm").

I AGREE to release the Indian River Riding Club and the Competition from ALL claims for money damages or otherwise for and Harm to my horse or me and for any Harm caused by me or my horse to others, even if the Harm Resulted, directly or indirectly, from the negligence of the Indian River Riding Club, it's officers/directors, or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Indian River Riding Club or the Competition.

I AGREE as a parent or guardian of a minor or as a participant that as a condition of and in consideration on of acceptance of entry, the Indian River Riding Club and/or the Competition may use or assign photographs, video, audios, cable cast, or the likenesses of me and my horse taken during the course of the competition for the promotion, coverage, or benefit of the competition, sport, or the Indian River Riding Club.
